

ALLIANZ BUSINESS SHIELD SALES CAMPAIGN TERMS AND CONDITIONS

The Allianz Business Shield Sales Campaign ("Campaign") which is organized by Allianz General Insurance Company (Malaysia) Berhad ("AGIC") is offered to policyholders with Allianz Business Shield ("ABS") policy issued through any distribution channel of AGIC. This Campaign is subject to the following terms and conditions.

1. Campaign Period

This **Campaign** will run from 15th May 2024 to 31st December 2024 or until the date when the total amount payable under this Campaign reaches RM100,000, whichever occurs earlier ("**Campaign Period**"). Notwithstanding the aforesaid, **AGIC** reserves the right to change the Campaign Period without prior notification.

2. Campaign Eligibility

The following are the criteria to be eligible for this **Campaign:**

- a. This **Campaign** is open to all policyholders who purchased a new or renewed their existing:
 - (i) ABS policy; AND
 - (ii) Student Personal Accident policy issued by AGIC ("SPA");
 during the Campaign Period, with the policies being issued within the Campaign
 Period ("Eligible Participant");
- b. When purchasing the ABS policy, the **Eligible Participant** must also fulfill the criteria as per the table below:

3. Campaign Benefit

- a. In the event the Eligible Participant's business is ordered to be closed by a relevant public authority for at least a minimum period of seven (7) days during the Campaign Period due to hand, foot and mouth disease, the Eligible Participant shall be entitled to a one-time payout of RM3,000.00 ("Campaign Benefit") under this Campaign.
- b. Both the ABS and SPA policies must be in force and issued to the same policyholder when lodging the claim for the **Campaign Benefit**.

4. Claim Process

- a. Below is the claim process:
 - (i) Submit the completed documents below to AGIC via email to AGIC.Campaign@allianz.com.my or to any AGIC branch office:
 - (1) Completed Allianz Business Shield Sales Campaign Claim Form;
 - (2) Notice of closure of business from public authority;
 - (3) Completed E-payment authorization form;
 - (4) Certificate of Registration of business; and
 - (5) Proof of bank account details (e.g. first page of bank statement).
 - (ii) Upon receipt of the documents above, AGIC will verify the claim entitlement.
 - (iii) Claims to be approved within 14 working days upon full submission of documents.
 - (iv) Claims payout via E-Payment (5 working days from approval of claim).
- b. For avoidance of doubt, notification of any claim for the **Campaign Benefit** must be submitted within thirty (30) days from the first date the **Eligible Participant** is required to close for business due to hand, foot and mouth disease.

5. Other Conditions

- a. By participating in this **Campaign**, the **Eligible Participants** hereby agree to be bound by the terms and conditions, and any decisions made by **AGIC** in respect of this **Campaign** which shall be final and conclusive.
- b. **AGIC** reserves the right and has the absolute discretion to vary the **Campaign Period**, and the other terms and conditions of this **Campaign**, and suspend, cancel

- c. **AGIC** shall not be liable for any direct or indirect loss or damage of any kind howsoever arising, suffered by the **Eligible Participants** or any person claiming through the **Eligible Participants** in connection with this **Campaign**.
- d. The processing of any personal data provided pursuant to this Campaign shall be in accordance with the Personal Data Protection Act 2010.
