

Fire Blanket for Allianz Business Shield Campaign Terms and Conditions

The **Fire Blanket for Allianz Business Shield Campaign** ("**Campaign**") which is organized by Allianz General Insurance Company (Malaysia) Berhad ("**AGIC**") is offered to policyholders with property(ies) covered under the Allianz Business Shield ("**ABS**") policy issued through any distribution channel of **AGIC**. This **Campaign** is subject to the following terms and conditions.

1. Campaign Period

This **Campaign** will run from 1st June 2024 to 31st December 2024 or until the total number of fire blankets to be given away under this **Campaign** reaches two thousand (2,000) units, whichever is earlier ("**Campaign Period**"). This giveaway is on a first come first served basis.

Each **Eligible Participant** shall be entitled to receive **one (1) fire blanket**, which will be sent within **thirty (30) working days** from the **ABS** policy issuance date. Only two thousand (2,000) units of such fire blankets are available to be given away during the **Campaign Period**.
