Section II: Loss of profit, loss of revenue, loss of rental, standing charges, wages or salaries on payroll basis and increase in cost of working due to business interruption as a result of loss or damage to property insured under Section I.

Two extensions of coverage :-

- 1. Machinery Breakdown and Loss of Profit Following Machinery Breakdown Extension (up to max RM2 million any one loss and in the aggregate)

This duty of disclosure shall continue until the time the contract is entered into, varied or renewed. You also have a duty to tell us immediately if at any time after your contract of insurance has been entered into, varied or renewed with us, any of the information given is inaccurate or has changed.
