## Investment Objective

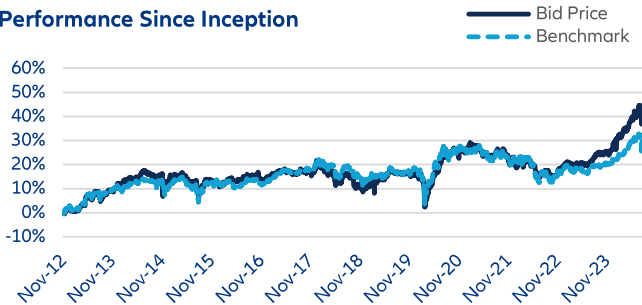

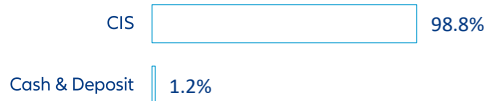
## Performance Since Inception
