

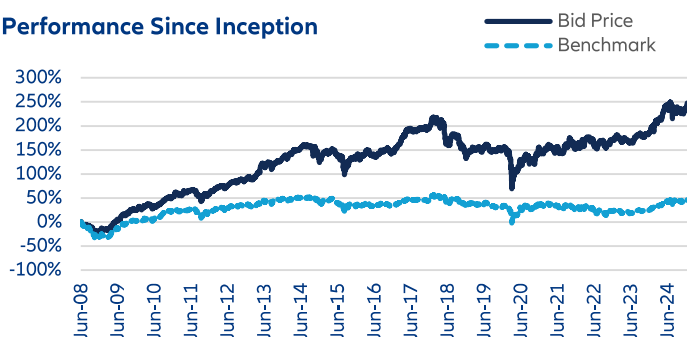

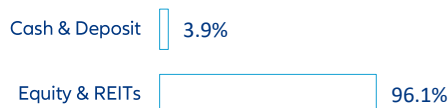
Investment Objective
