

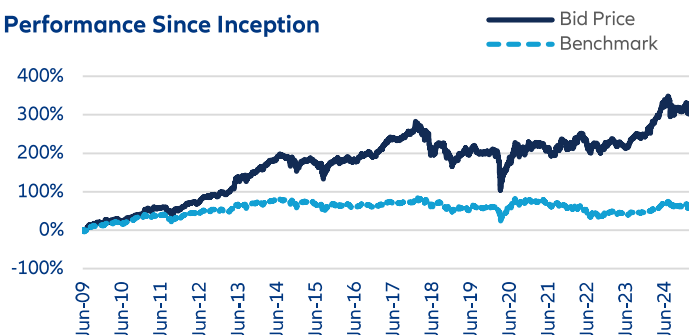

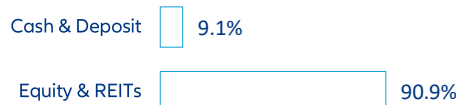
Investment Objective
