

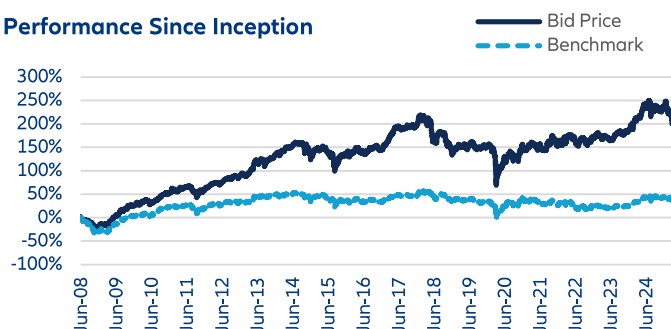

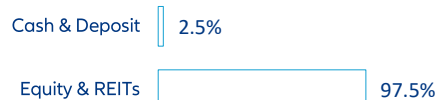
Investment Objective
