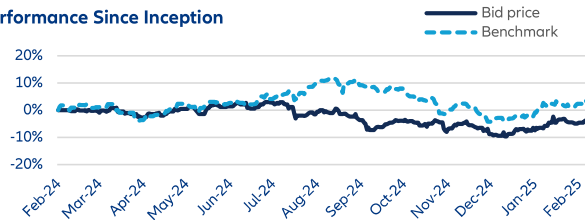

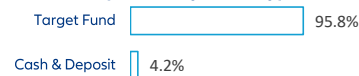

Portfolio Composition by Asset Type

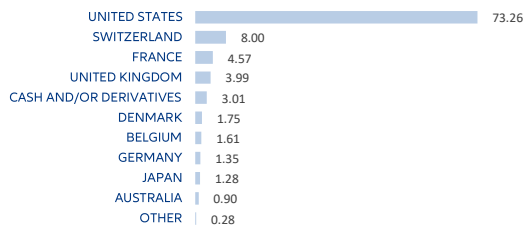

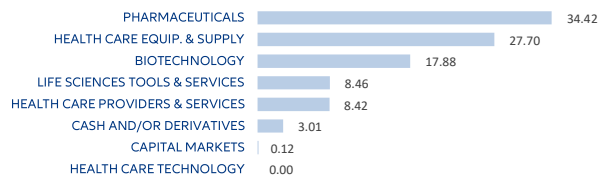
