# Allianz Road Rangers Rumble Competition Terms and Conditions

The Allianz Road Rangers Rumble ("Competition") is organised by Allianz General Insurance Company (Malaysia) Berhad ("Allianz Malaysia") where participants stand a chance to win prizes, subject to the terms and conditions herein.

2. Allianz Malaysia may at its absolute discretion extend the Competition Period at any time without any prior notice. Unless the Competition Period is extended and announced by Allianz Malaysia, any participation beyond the Competition Period will be disregarded.
