

Allianz "Travel on Holi-yay" Campaign Terms and Conditions

Allianz Travel on Holi-yay Campaign ("Campaign") is organised by Allianz General Insurance Company (Malaysia) Berhad ("AGIC") and shall be subject to the terms and conditions contained herein.

1. Campaign Period

This **Campaign** will run from 1st November 2024 until 30th November 2024 ("**Campaign Period**"). Notwithstanding the aforesaid, **AGIC** reserves the right to change the **Campaign Period** without prior notification.

2. Eligibility

To be eligible to participate in this **Campaign**, the following criteria must be met:

- a) the Allianz Travel Care ("ATC") or Allianz Travel Easy ("ATE") policy must have been purchased during the Campaign Period;
- b) the individual policyholder must be covered under a Domestic or Overseas single-trip coverage (and not an annual coverage) under the following plans under the **ATC** or **ATE** policy;
 - i) Adult Plan;
 - ii) Senior Citizen Plan;
 - iii) Child Plan; or
 - iv) Family Plan.

The policyholders who fulfil the criteria above will be deemed as the eligible participants ("Eligible Participants") and will enjoy a discount on the premium for their ATC or ATE policy, subject to the Campaign Terms and Conditions.

3. Campaign Terms and Conditions

a) This **Campaign** shall not be applicable to the **ATC** or **ATE** policies issued on an annual coverage basis.



- b) **Eligible Participants** shall be entitled to a twenty percent (20%) discount ("**Discount**") on the basic premium payable excluding any rider(s) for their **ATC** or **ATE** policy if they fulfill the criteria of this **Campaign**.
- c) The **Discount** can be applied by using the code "**HOLIYAY20**%" during the purchase of the **ATC** or **ATE** policy.
- d) In the event the **Eligible Participant** purchases more than one (1) **ATC** or **ATE** policy during the **Campaign Period**, he/she shall be entitled to the **Discount** for each **ATC** or **ATE** policy.

4. Other Conditions

- a) By participating in this **Campaign**, the **Eligible Participants** hereby agree to be bound by the terms and conditions stipulated herein and all decisions made by **AGIC** in respect of this Campaign which shall be final and conclusive.
- b) AGIC reserves the absolute right and discretion to cancel, terminate or suspend this Campaign or vary its terms and conditions without any prior notice or reason. For the avoidance of doubt, the Eligible Participants hereby agree that they are not entitled to any form of compensation whatsoever arising from any losses or damages incurred as a direct or indirect result of the said cancellation, termination, suspension or variation by AGIC.
- c) AGIC shall not be liable for any direct or indirect loss or damage of any kind howsoever arising, suffered by the Eligible Participants or any person claiming through the Eligible Participants in connection with this Campaign.
- d) The processing of any personal data provided pursuant to this **Campaign** shall be in accordance with the Personal Data Protection Act 2010.
